मद्य निषेध, उत्पाद एवं निबंधन विभाग में 'मद्य निषेध सिपाही' पद की 689 रिक्तियों के लिए आयोजित लिखित परीक्षा का परिणाम

---

केन्द्रीय चयन पर्षद (सिपाही भर्ती) द्वारा बिहार राज्य में मद्य निषेध, उत्पाद एवं निबंधन विभाग में 'मद्य निषेध सिपाही' पद की 689 रिक्तियों के विरुद्ध सीधी भर्ती हेतु दिनांक 12.11.2022 को विज्ञापन संख्या 02/2022 राज्य के प्रमुख समाचार-पत्रों तथा पर्षद के वेबसाइट पर प्रकाशित किया गया था।

2. उक्त विज्ञापन के क्रम में दिनांक 14.05.2023 (रविवार) को कुल 3,65,215 (तीन लाख सैंसठ हजार दो सौ पन्द्रह) अभ्यर्थियों की लिखित परीक्षा आयोजित की गई। लिखित परीक्षा में 2,69,370 अभ्यर्थी सम्मिलित हुए। 207 अभ्यर्थी कदाचार के आधार पर अयोग्य घोषित किए गए। 13,276 अभ्यर्थियों की उत्तर पुस्तिकाओं को गलत/अपूर्ण सूचना अंकित करने के कारण अभ्यर्थिता रद्द की गयी तथा 2,55,887 अभ्यर्थियों की उत्तर पुस्तिकाओं का मूल्यांकन किया गया। तदोपरान्त भर्ती हेतु विहित प्रक्रिया का अनुसरण करते हुए विभिन्न कोटियों के लिए मूलतः उपलब्ध रिक्तियों के पाँच (05) गुणा उम्मीदवारों का लिखित परीक्षा के आधार पर शारीरिक दक्षता परीक्षा {Physical Efficiency Test (PET)} के लिए मेधाक्रमानुसार आरक्षण कोटिवार चयन किया गया।

3. अगले चरण में अभ्यर्थियों को प्रमाण-पत्रों के सत्यापन के साथ-साथ, शारीरिक दक्षता परीक्षा (PET) यथा- दौड़, गोला फेंक तथा ऊँची कूद आदि में सम्मिलित एवं उत्तीर्ण होना अनिवार्य होगा। शारीरिक योग्यता के न्यूनतम निर्धारित मापदण्ड में कोई छूट अनुमान्य नहीं होगी। मद्य निषेध सिपाही पद पर नियुक्ति हेतु चयन के लिए अंतिम मेधा सूची शारीरिक दक्षता परीक्षा के अधीन तीनों स्पर्धाओं (यथा-दौड़, ऊँची कूद एवं गोला फेंक) में प्राप्त कुल अंकों के आधार पर तैयार की जायेगी।

4. लिखित परीक्षा के आधार पर अगले चरण "शारीरिक दक्षता परीक्षा" के लिए पात्र अभ्यर्थियों का परीक्षाफल यहाँ प्रकाशित किया जा रहा है। **शारीरिक दक्षता परीक्षा के संबंध में सूचना अलग से प्रकाशित की जाएगी।**

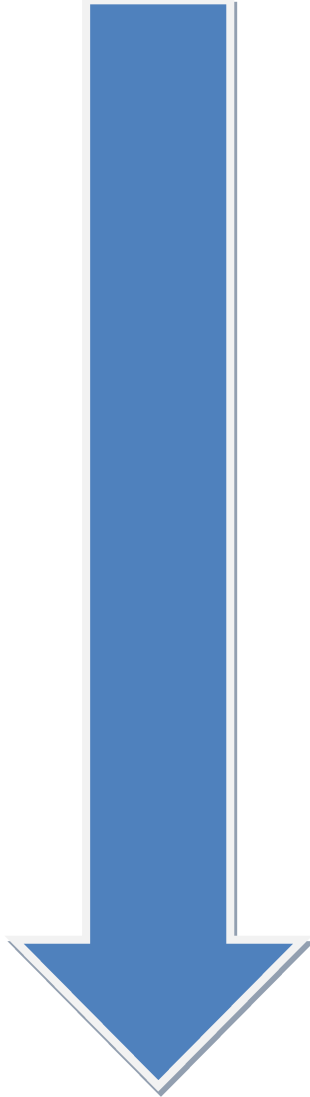
